A senior in the last term, not counting the student teaching semester, who does not need to carry a full load of undergraduate work for the baccalaureate degree may enroll in graduate courses, if the total number of hours does not exceed a normal load. The student will receive graduate credit only if the requirements for the bachelor's degree are completed at the end of the term during which the student is so enrolled, or the following term if it is the student teaching semester.
