

**Minutes  
Academic Council  
April 7, 2015**

**A. MINUTES:**

Upon a motion by McDougall; seconded by McGowan, the minutes of March 3, 2015, were unanimously approved.

**B. ACTION ITEMS:**

Rogers-Adkinson moved approval of Action Items 1-7 – curriculum revisions to the BSED Art Education; deletion of the BSED Business Education program; curriculum revisions to the BSED Physical Education, BSED Secondary Education/English, BSED Secondary Education/French, BSED Secondary Education/German, and BSED Secondary Education/Spanish; seconded by McGowan/McDougall. Rogers-Adkinson moved to amend all curriculum revisions to remove UI506 (Education, Law and Society) and make SE365 (Pedagogy 2: Secondary School – Interdisciplinary Methods and Technology) a 4 credit hour course; seconded by McGowan (McDougall expressed his approval of the amendment). Rogers-Adkinson explained that these changes are the result of a high number of hours in the pedagogy content. The overall curriculum revisions are to align the programs with the new Missouri Standards for Professional Educators (MoSPE) and DESE certification requirements. Rogers-Adkinson expressed appreciation for the faculty in the College of Education and the departments with secondary education programs for their work in getting the programs revised. Eddleman echoed his thanks. McDougall noted that he and the College of Business were in favor of deleting the BSED Business Education program, as it has been a low enrolled program for years. Hinkle noted that when she received the first proof of the Bulletin, she'll try to make the changes. Rogers-Adkinson also thanked Hinkle for working with the College of Education on all the revisions. McGowan made a friendly amendment to the March meeting curriculum revisions to remove UI506 and make SE365 a 4 credit hour course; seconded by Rogers-Adkinson. Motion, with amendments, passed unanimously.

**8. BSFCSE Family and Consumer Sciences Education – Curriculum Revisions**

Jenkins moved approval of the curriculum revisions to the BSFCSE Family and Consumer Sciences Education program; seconded by Rogers-Adkinson. Branscum explained that there was a change that needed to be made to the proposal, as the content portion is short by six credit hours at the senior level; two courses, CF402 (Relationships of Commitment) and UI445 (Social Perspective of Sexuality) will be added to the content area. Branscum made a friendly amendment to make this change to the motion; seconded by Rogers-Adkinson. Branscum also pointed out that some of the course titles in the proposal are wrong and should be corrected – FN235 should be Nutrition for Health; HM205 should be Basic Culinary Techniques, and UI340 should be Housing Perspectives. Motion, with amendment, passed unanimously.

**9. Master of Arts in Applied Behavior Analysis – New Program**

Rogers-Adkinson moved approval of a new Master of Arts in Applied Behavior Analysis program; seconded by Jenkins. Severtson explained that the program is 42 credit hours, with 18 credit field work hours. The curriculum allows students to sit for the national certification exam. Rogers-Adkinson noted that there are already 16 students that have expressed interest in the program, with some already enrolled in coursework. McGowan questioned the wording on the Student Enrollment Projection page about new students only being able to enroll in the Fall semesters; Severtson explained that this means that new students will only be allowed to enter the program in Fall semesters, based on the rotation of courses. Eddleman suggested rewording the paragraph. Motion passed unanimously.

**10. Cybersecurity in Business Systems – New Minor**

McGowan moved approval of a new minor, Cybersecurity in Business Systems; seconded by Jenkins/McDougall. McGowan explained that the minor was developed in cooperation with the College of Business; it was developed primarily for Accounting majors, but any major can take the minor. He noted that the Digital Forensics course still needs to be developed, and that there are some hidden prerequisites, specifically for the math course. McDougall thanked McGowan (and Brad Deken and Vijay Anand) for developing the minor, as the College of Business had approached them about developing it based on the needs of their students. Motion passed unanimously.

**D. Other:**

1. McGowan stated that the Math Education curriculum revisions would be coming forward to the May Academic Council meeting. Rogers-Adkinson noted that Math and Music are the only revisions left to come forward.
2. Eddleman explained that regarding the University Studies proposal that was tabled at the March meeting, until the University Studies program is reviewed, he will consider any proposals that come forward to him and will allow the programs that warrant it, to require only one UI3XX level course. Education has already proposed this. McGowan added that all ABET programs would. Barrios added that Music would likely do so.

Upon a motion by McGowan; seconded by Rogers-Adkinson, the meeting adjourned.
